Rural Media is a Hereford-based production company and charity in the UK that produces award-winning films and digital arts projects. Founded 30 years ago by CEO Nic Millington, the organization has a reputation for telling powerful stories from unheard voices and nurturing creative talent.

Rural Media Charity collaborates with communities, schools, groups, and individuals to create issue-driven films, heritage, and digital arts projects that raise awareness, influence change, and celebrate rural life. Rural Studios, the sister company of Rural Media Charity, produces content for national broadcasters, online platforms, and social media for charities and businesses of all sizes. Income from production is reinvested into the charity to ensure media participation and production continue to thrive in Herefordshire and beyond.

A NEED TO MANAGE EMAIL SECURITY AND SHARING PERMISSIONS

Melanie Page, Data and Office Manager at Rural Media, explained that the company initially had an on-premise firewall with Active Directory, that only provided anti-spam and antivirus protection. They lacked traceability of emails, a management console, and a permission reporter. Sharing was limited to email with no control over it. When Rural Media migrated from an on-premise server to Microsoft 365, including email, SharePoint, and OneDrive, this triggered the need for enhanced security solutions.

Ms Page explained that management was concerned about the risks presented by allowing the company-wide team to directly share files with people outside their organisation. Because Rural Media is a registered charity, they have various regulations to comply with, especially regarding data management.

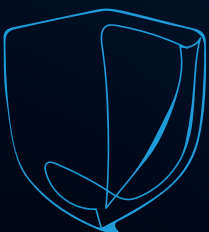
For greater productivity and innovation, it was critical for them to ensure the team would have more flexibility to create new content and work with third parties, while at the same time giving the management team control over the files in SharePoint that were being shared. From a system management perspective, they also wished to have a single and simple dashboard that was shared with Tate.

Andy Truelove, Lead Engineer and co-owner of Tate, had already worked with Hornetsecurity's email security products. SIMPLIFIED DAILY MANAGEMENT OF POSSIBLE THREATS

Melanie Page said that the product's weekly reports on suspicious activity and the ability to rectify issues in the portal have been beneficial. She views it as one gatekeeper that manages the system, simplifying daily operations.

Mr Truelove highlighted the big improvement in terms of the identification of phishing emails. Another big plus for his IT services company is the ability for Rural Media users to whitelist their emails and to manage this themselves without having to contact Tate to release an email that was potentially flagged as spam.

To him, the experience around the implementation and migration of the email security solution confirmed that they choose the best provider.
